

## **Toshiba International Corporation Privacy Policy Statement**

Toshiba International Corporation (“TIC”) has created this privacy statement in order to demonstrate our firm commitment to privacy. The following discloses our information gathering and dissemination practices for this website: [www.toshiba.com/ind](http://www.toshiba.com/ind).

When you visit our Site, we collect certain routing information such as the Internet Protocol address of your originating Internet Service Provider, and limited information provided by “cookies” stored on your hard drive. TIC uses this information to help diagnose problems with our server, to administer our Web site, and to provide you with a better experience using our Web site. TIC collects and maintains statistics about the Web servers used to contact us, which help us track the total number of visitors to the site and to specific parts of the site. We may disclose information about you or your company if we have a good faith belief that we are required to do so by law or legal process, to respond to claims, or to protect the rights, property or safety of TIC or others.
